## What is the Drug and Alcohol Court?

The Drug and Alcohol Court is a court that deals with offences that relate to serious drug and alcohol use. The magistrate can give you a Drug and Alcohol Treatment Order (Treatment Order) where you complete a two-year treatment program in the community while on a suspended sentence. You need to agree to a Treatment Order. The court has treatment and support programs to help you.

## How do I get a Treatment Order?

The magistrate will need to refer you to the Drug and Alcohol Court in Brisbane.

You, your family or your lawyer need to:

**Get the form:** Drug and Alcohol Court *Form 1 Referral Form* from the Magistrates Court, the Queensland Courts website or your lawyer.

**Complete the form:** Duty lawyers at the court—or lawyers from Legal Aid Queensland (LAQ) or Aboriginal and Torres Strait Islander Legal Service (ATSILS)—can help you or your family with this.

Your lawyer will give this form to the magistrate who may then refer you to the Drug and Alcohol Court. You will need to talk to people at the Drug and Alcohol Court about your drug and alcohol use and your offending. This information will help the court decide if you should receive a Treatment Order.

## Why should I get a Treatment Order?

The Treatment Order supports you to get your life back on track.

To successfully complete your order you will have to do everything the court tells you to do. That means attending treatment, regularly coming back to court and being drug and alcohol tested.

## Where is the Drug and Alcohol Court?

The Drug and Alcohol Court is on level four of the Brisbane Magistrates Court. The court has its own magistrate and a team of people to help you with your Treatment Order.

This team includes:

- » Aboriginal and Torres Strait Islander Cultural Liaison Officer
- » Lawyers from LAQ or ATSILS to represent you
- » Queensland Corrective Services officers who will supervise and ensure you comply with your order
- » Queensland Health clinicians to help with your medical and treatment needs
- » Prosecutors from the Queensland Police Service.

The magistrate will know who you are, and the people at court working with you will tell the court how you are progressing.

## How does it work?

The treatment program lasts for two years. Once the court gives you a treatment order you will need to talk to a health clinician and Corrective Services officer to find the best treatment plan for you. As well as completing the treatment, you will need to attend court a lot so you can talk to the magistrate about your progress and any troubles you are facing.

You will not be allowed to use drugs or alcohol and you will be regularly tested. The court and team—including the Aboriginal and Torres Strait Islander Cultural Liaison Officer—will support you while you complete your order.

## What happens if I break my Treatment Order?

The court understands things may be very difficult for you. The magistrate will work with you to understand why you broke the order.

The court may then ask you to do extra things such as come to court more regularly or do some community service—or you might have to go to jail for short periods. If you decide you do not want to complete your treatment program, you may be sent to jail as part of your sentence.

## Is this the same as the Murri Court?

No, the Murri Court is different and has locations all over Queensland. Murri Court may refer to the Drug and Alcohol Court. If you are using the Drug and Alcohol Court, the Cultural Liaison Officer and Elders will help you.

## Am I eligible?

- ✓ Live in the Brisbane area
- ✓ Are likely to be sentenced to jail
- ✓ Plead guilty in a Magistrates Court
- ✓ Have a severe problem with drugs or alcohol

- ✗ If you are currently serving a prison sentence
- ✗ If you are already on parole
- ✗ If you are charged with sexual assault offence/s
